第一條

國立臺北大學（以下簡稱本校）為鼓勵專任教師（含各單位自行遴聘之專案教師、依本校約聘教學人員聘任辦法聘任之約聘教學人員）、兼任教師、合聘教師、客座講座及研究人員（含編制內研究人員、博士後研究人員、計畫研究人員）發表學術研究成果，提昇學術研究水準，特訂定本辦法。

第二條

本辦法獎助範圍包括學術期刊論文、學術專書及學術專書論文。

第三條

學術期刊論文申請條件：

- 一、 本校專任教師（含各單位自行遴聘之專案教師、依本校約聘教學人員聘任辦法聘任之約聘教學人員）及編制內研究人員，以本校名義（含跨校或跨單位合作之論文）發表刊登收錄於 SCIE、SSCI、A&HCI、TSSCI 名單、EI（限 Compendex）、CIS、JEL、Econlit、ILP、WestLaw、THCI 名單、TCI-HSS、Scopus 資料庫之期刊論文，或經由各學院認定之 THE World University Rankings 或 QS World University Rankings 世界大學排名前 500 名之國外大學出版之學術期刊論文（以上不含會議論文）。
- 二、 本校兼任教師、合聘教師、客座講座、博士後研究人員及計畫研究人員，以本校名義發表刊登收錄於 SCIE、SSCI、A&HCI、Scopus 資料庫之期刊論文。
- 三、 申請之文章須為前一年度內（1 月 1 日至 12 月 31 日）刊登者（以論文所屬卷期發表年代為準）。

出版學術性專書申請條件：

- 一、 本校專任教師（含各單位自行遴聘之專案教師、依本校約聘教學人員聘任辦法聘任之約聘教學人員）及編制內研究人員，以著作人身分發表，且作者之介紹須包含有國立臺北大學（或 National Taipei University）字樣者。
- 二、 獎助之專書須為前一年度內（1 月 1 日至 12 月 31 日）出版者。

- 三、 學術性專書指針對特定研究議題進行深入的、系統性的探討，具有導論及原創性的結論，且附有參考書目並具 ISBN 國際標準書號者，一般教科書、文藝創作、翻譯著作、譯注、會議論文集、已發表之論文彙編、研究成果報告不在受理申請範圍。
- 四、 獎助之專書須由具出版學術性專書之出版單位，經一定之審查程序後出版。
- 五、 出版單位之審查，至少應包含相關領域之專家學者五人組成編審委員會進行審查，或由二位以上評審以非公開方式審查。
- 六、 如申請人未列名專書作者，僅在特定篇章列名作者，該篇章視為專書論文。

出版學術專書論文申請條件：

- 一、 本校專任教師（含各單位自行遴聘之專案教師、依本校約聘教學人員聘任辦法聘任之約聘教學人員）及編制內研究人員，以著作人身分發表，且作者之介紹須包含有國立臺北大學（或 National Taipei University）字樣者。
- 二、 獎助之學術專書論文須為前一年度內（1月1日至12月31日）出版者。
- 三、 一般教科書、文藝創作、翻譯著作、譯注、會議論文集、已發表之論文彙編、研究成果報告不在受理申請範圍。
- 四、 獎助之學術專書論文須由具出版學術性專書之出版單位，經一定之審查程序後出版。
- 五、 出版單位之審查，至少應包含相關領域之專家學者五人組成編審委員會進行審查，或由二位以上評審以非公開方式審查。

有關期刊收錄於相關資料庫之認定，依論文所屬卷期為依據；國外大學在THE World University Rankings 或 QS World University Rankings 世界大學排名之認定，依最近3年（依徵件截止日時，網站公告之最新年度資料為計算時點）為依據。

前項申請人如能證明著作投稿時，期刊收錄在相關資料庫或出版著作之大學在 THE World University Rankings 或 QS World University Rankings 世界大學排名前500名，並檢附證明文件，得以投稿時認定。

第四條

依本辦法提出之獎助申請，須符合國家科學及技術委員會學術倫理規範，並須經獎助審查委員會審查通過。

申請案件如有違反學術倫理規範疑慮者，依「國立臺北大學教師違反送審教師資格規定及學術倫理案件處理辦法」處理。

本校獎助審查委員會置委員若干人，由學術副校長召集教務長、研發長及各學院院長組成之，負責審查事宜。

審查委員有提出申請案件者，應迴避與該申請案有關之審查事宜。

年度實際獎助額度及個人獎助最高額度，視當年度經費狀況由審查委員會審議決定之。

第五條

學術期刊論文收錄於 SCIE、SSCI 資料庫者，依期刊所屬領域，以 JCR 資料庫 Category 索引 Rank by Journal Impact Factor 查詢，採計最近三年內（依徵件截止日時，該網站公告之最新年度資料為計算時點）最優排名百分比，獎助方式如下：

- 一、 該領域排名前1%（含）者，每篇論文最高獎助新臺幣100萬元。
- 二、 該領域排名前5%（含）者，每篇論文最高獎助新臺幣10萬元。

- 三、該領域排名前 25%（含）者，每篇論文最高獎助新臺幣 2 萬 5 千元。
- 四、該領域排名在前三款以外者，每篇論文最高獎助新臺幣 2 萬元。
- 五、本項第一款、第二款僅適用於本校專任教師（含各單位自行遴聘之專案教師、依本校約聘教學人員聘任辦法聘任之約聘教學人員）及編制內研究人員。

學術期刊論文收錄於 A&HCI、TSSCI、THCI 資料庫或經各學院認定之 THE World University Rankings 或 QS World University Rankings 世界大學排名前 500 名之國外大學出版者，每篇論文最高獎助新臺幣 2 萬元。

學術期刊論文收錄於 Scopus 資料庫者，每篇論文最高獎助新臺幣 1 萬元。

學術期刊論文收錄於 EI（限 Compendex）、CIS、JEL、Econlit、ILP、WestLaw、TCI-HSS 資料庫者，每篇論文最高獎助新臺幣 8 千元。

本校兼任教師、合聘教師、客座講座、博士後研究人員及計畫研究人員，以本校名義發表刊登收錄於 SCIE、SSCI、A&HCI、Scopus 資料庫之期刊論文，獎助金依本條及第八條作者序認定計算後之金額折半發放。

第六條

學術性專書，經由各學院認定之 THE World University Rankings 或 QS World University Rankings 世界大學排名前 500 名之國外大學出版者，每本專書最高獎助新臺幣 4 萬元，其餘每本專書最高獎助新臺幣 2 萬元。

第七條

學術專書論文，經由各學院認定之 THE World University Rankings 或 QS World University Rankings 世界大學排名前 500 名之國外大學出版者，每篇最高獎助新臺幣 2 萬元，其餘每篇最高獎助新臺幣 5 千元。

第八條

獨立作者以全額獎助金及獎狀乙紙獎助。

合作著作之作者獎助原則如下：

- 一、第 1 作者或通訊作者：百分之七十之獎助金及獎狀乙紙。
- 二、第 2 作者：百分之五十之獎助金及獎狀乙紙。
- 三、第 3 作者（含）以後：獎狀乙紙。

前項合作著作之第 1 作者有 2 名以上時，第 2 作者依第 3 作者獎助。

第二項第一款、第二款之第 1 作者或通訊作者、第 2 作者有 2 名以上時，獎助金依該款之獎助金除以總第 1 作者或總通訊作者、總第 2 作者人數計算。

合作著作之申請人得依第二項至第四項規定計算後，擇最有利之方式獎助。

為鼓勵教師進行國際合作研究，第二項第一款、第二款之獎助金申請人，其著作合著人之一於作品中所列工作單位隸屬國外（含中國大陸、香港及澳門）學術研究機構者，得比照獨立作者獲全額獎助金及獎狀乙紙。

每篇文章或每本專書及專書論文以獎助一人為限；文章由數人合著者，優先獎助第 1 作者。

第九條

本校得增訂加強實質審查期刊名單，投稿於加強實質審查期刊之申請案，應經獎助審查委員會個案審查，申請人應於申請時一併檢附以下文件，作為審查委員實質審查之輔助資料：

- 一、投稿期程。
- 二、審查意見回覆歷程。
- 三、其他（如：論文實質學術內涵等）有助審查之文件。

第十條

申請人應於每年九月一日至九月三十日至線上系統填寫申請表並上傳下列文件後送出申請：

- 二、學術期刊論文：論文抽印本。
- 二、出版學術性專書：
 - (一) 書本封面（含作者介紹）及版權頁影本。
 - (二) 出版單位寄送出版合約書影本。
 - (三) 出版單位編審委員名冊或二位以上評審委員之審查意見影本一份。
- 三、出版學術專書論文：
 - (一) 書本封面（含作者介紹）及版權頁影本。
 - (二) 出版單位寄送出版合約書影本。
 - (三) 出版單位編審委員名冊或二位以上評審委員之審查意見影本一份。
 - (四) 論文抽印本。

第十一條

符合申請條件但未及於公告受理期限內提出者，得申請認列前一年度學術著作，補發獎狀乙紙。

第十二條

本辦法之經費來源由指定用途捐款、自籌收入之盈餘及募款支應。

本辦法第五條第一項第一款、第二款獎助金由指定用途捐款支應，該經費來源如經中止，第五條第一項第一款、第二款獎助金額度比照第五條第一項第三款獎助金額度發放。

第十三條

申請人同一年度同一學術研究成果事由（即同一篇期刊論文、專書論文或同本專書），校內各種獎勵金不得重複支領。

申請人於支領本校特聘教授、特殊優秀人才獎勵金期間，不得申請本獎助。

依本辦法第五條第一項第一款、第二款規定申請之獎助，不受前兩項規定限制。

第十四條

本辦法應經校務基金管理委員會決議提請校務會議通過後，陳請校長發布實施；修正時亦同。










